## REGULAR MEETING OF THE CHAIRPERSON AND BOARD OF TRUSTEES OF FAIRMONT NEBRASKA

Monday, June 11, 2018

The Regular meeting of the Fairmont Village Board of Trustees was convened in open and public session on Monday, June 11, 2018 at 7:00 p.m. at the Fairmont Village Hall, 635 6th Ave., Fairmont NE. Notice of the meeting was given in advance according to proper notification by posting of meeting notice at Heartland Bank-Fairmont Branch, U.S. Post Office and Fairmont Village Hall. Acting Chairperson David R. Seggerman called the meeting to order. Clerk/Treas. Linda Carroll recorded the minutes. Board members present upon roll call were: Jack R. Slocum, Aaron T. Fintel and Acting Chairperson Seggerman. Chairperson Donald A. Moses and Trustee Selina J. West were absent. Visitors to the meeting were: Jeff Neiman, Skip Radke, Elizabeth Long, Jennifer Slezak, Leah Kottwitz, Chris & Aislee Grant, Lynn West, Tyler Salmon and Dan Slocum. Acting Chairperson Seggerman noted that a copy of the Open Meetings Act was posted in the council meeting room for public inspection and review. Fintel moved and Slocum seconded to approve the minutes of the May 14, 2018 board meeting. Voting aye: Fintel, Slocum and Seggerman. Absent: Moses and West. Motion approved. April 30, 2018 Treasurer's Report was placed on file.

#### **PUBLIC FORUM**

Skip Radke visited with the board regarding: 1) Structural condition of City Park and Ballfield Park restrooms – need to have a building inspector come and look restrooms as they are in disrepair- John Hughes, Building Inspector will be instructed to look at ballfield park and city park restroom structures; 2) Mowing around street light power control on right of way property – Skip stated in the past the village mowed around the lighting control center-Trustee Slocum stated the village would continue mowing around the lighting control center; 3) Manning Grain–Skip requested the village corresponded with Manning Grain on their rail crossings at "F" Street and "G" Street on east side of town - village will contact Manning Grain; 4)Horse shoe pitching area at Swim pool park– should have a 12' peak of the arch of a covering over the area – Skip said he would be willing to get estimates for the covering.

#### **PUBLIC HEARING 7:13 P.M.**

Acting Chairperson Dave Seggerman opened a public hearing at 7:13 p.m. to receive comments on the following proposed amendment to the current village zoning regulations governing the following:

- -5.2.02 Permitted Principal Uses and Structures #3 animal limitations...(unless operating under an approved Conditional Use Permit)
- -5.2.04 Conditional Uses Item #13 Expansion of existing intensive livestock confinement facilities in the AG-2 agricultural district by conditional use".
- -9.20 Intensive Livestock Facilities/Operation #2 on be allowed in the AG-1 and AG-2 Agricultural districts; and must comply with the following conditions unless operating under and approved Conditional Use Permit which specifically relaxes or waives said condition:.

Zoning Administrator Jennifer Slezak reported: 1) Fillmore County Planning Committee met on May 21, 2018 and recommended approval of the amendment; 2) Areas amending would allow for an increase in the number of head of livestock permitted by granting a conditional use permit; 3) Elizabeth Long inquired about the public notice sent to adjoining property owners regarding

the conditional use permit to Circle Five Feed Yard to expand the current operation an additional 2,500 head of cattle with a confinement barn—Jennifer stated the notice of the public hearing was sent to property owners within a one-mile radius of the Circle Five property and the public hearing for the conditional use permit request would be the June 18, 2018 county planning commission meeting and the public hearing for the increase in livestock and conditional use permit request would be at the July 9, 2018 village board meeting; 4) Public hearing remained open as the board continued on with the agenda.
