# REGULAR MEETING OF THE CHAIRPERSON AND BOARD OF TRUSTEES OF FAIRMONT NEBRASKA

May 13, 2019

The Regular Meeting of the Fairmont Village Board of Trustees was convened in open and public session on Monday, May 13, 2019 at 7:00 p.m. at the Fairmont Village Hall, 635 6th Ave., Fairmont NE. Notice of the meeting was given in advance according to proper notification by posting of meeting notice at Heartland Bank-Fairmont Branch, U.S. Post Office and Fairmont Village Hall. Acting Chairperson David R. Seggerman called the meeting to order. Clerk/Treas. Linda Zuerlein recorded the minutes. Board members present upon roll call were: Chris Grant and Larry E. Klipp. Absent: Tricia Galusha-Chapman and Chairperson Aaron T. Fintel. Visitors to the meeting were: Scott Childers, Georgia Schropfer, Connie Jo Felton, Linda Richters, Wanda Marget, Linda Chambers, Rain, Al Engelhardt, Tylor Salmon and Dan Slocum. Acting Chairperson Seggerman noted that a copy of the Open Meetings Act was posted in the board meeting room for public inspection and review. Klipp moved and Grant seconded to approve the minutes of the April 11, 2019 board meeting. Voting aye: Klipp, Grant and Seggerman. Absent: Galusha-Chapman and Fintel. Motion approved. March 31, 2019 Treasurer's Report was placed on file.

## **PUBLIC FORUM**

Raine and Al Engelhardt visited with the board regarding the condition of alley located east of their home at 400 A Street(the alley is used as entrance to the property). Village maintenance personnel will put additional gravel in alley once dry. Raine inquired if the Village would put additional gravel where their vehicles are parked, they would pay for the gravel. Maintenance personnel will place extra gravel where needed for parking when conditions allow.

## **COLLINS CONSTRUCTION**

## LIBRARY BOARD

Scott Childers, Executive Director, Southeast Library System, reviewed various State of Nebr. Statues regarding public libraries in Nebraska, specifically section 51-207 which state Library Board has control of expenditures which would cover reimbursement of mileage. The Current Village policy requiring the Chairperson to approve mileage reimbursement funds may be in conflict with this section of the State Statues. Village attorney Campbell will be contacted for an opinion on this issue.

## **ELECTRONIC SIGN REPAIRS**

Wanda Marget reviewed information on repairs for the electronic sign. Items discussed: 1) 2016 repairs were \$912.30; 2) Sign life span are 10 - 12 years – original sign was purchased is June

2007; 3) Love Sign, Grand Island, repair technician could come out—labor charge \$110/hour, plus mileage; 4) New sign between \$10,000 - \$20,000; 5) General consensus of the board was to have the technician come out and look at the sign with a \$2,000 limit for repairs.
