# ORDINANCE #18-528 –\$250,000 STREET IMPROVEMENT BONDS AND CREATE STREET IMPROVEMENT DISTRICT NO. 2018-1

Seggerman introduced Ordinance #18-528 AN ORDINANCE CREATING DESIGNATING AN AREA AS STREET IMPROVEMENT DISTRICT NO. 2018-1 WITH REGARD TO STREET IMPROVEMENTS COMPLETED AT PUBLIC COST AND AUTHORIZING THE ISSUANCE OF A DISTRICT IMPROVEMENT BOND OF THE VILLAGE OF FAIRMONT, NEBRASKA, IN THE PRINCIPAL AMOUNT OF TWO HUNDRED FIFTY THOUSAND AND 00/100 DOLLARS (\$250,000.00) FOR THE PURPOSE OF PAYING THE COST OF STREET IMPROVEMENTS IN STREET IMPROVEMENT DISTRICT 2018-1, PRESCRIBING THE FORM OF BOND, PROVIDING FOR THE LEVY OF TAXES TO PAY THE BOND, ENTERING INTO A CONTRACT ON BEHALF OF THE VILLAGE WITH THE HOLDER OF THE BOND AND ORDERING THE ORDINANCE PUBLISHED IN PAMPHLET FORM and moved to suspend the readings on three separate days. Moses seconded the motion. Voting aye: Seggerman, Moses, Slocum, Klipp and Fintel. Motion approved. Slocum moved and Klipp seconded to pass and adopt Ordinance #18-528.
