# REGULAR MEETING OF THE CHAIRPERSON AND BOARD OF TRUSTEES OF FAIRMONT NEBRASKA

Monday September 10, 2018

The Regular meeting of the Fairmont Village Board of Trustees was convened in open and public session on Monday, September 10, 2018 at 7:00 p.m. at the Fairmont Village Hall, 635 6th Ave., Fairmont NE. Notice of the meeting was given in advance according to proper notification by posting of meeting notice at Heartland Bank-Fairmont Branch, U.S. Post Office and Fairmont Village Hall. Chairperson Donald A. Moses called the meeting to order. Clerk/Treas. Linda Carroll recorded the minutes. Board members present upon roll call were: Jack R. Slocum, Larry E. Klipp and Aaron T. Fintel. Absent: David R. Seggerman. Visitors to the meeting were: Marcus Harlow, Chris Grant, Paul Bettger, Georgia Schropfer, Jamey Pankoke, Angie Meyer, Stormy Meyers, Jeff Neiman, Wanda Moses, Tyler Salmon and Dan Slocum. Chairperson Moses noted that a copy of the Open Meetings Act was posted in the council meeting room for public inspection and review. Slocum moved and Klipp seconded to approve the minutes of August 13, 2018 and August 21, 2018 board meetings. Voting aye: Slocum, Klipp, Fintel and Moses. Absent: Seggerman Motion approved. # MARCUS HARLOW, HARLOW HOMES, YORK NE

Marcus Harlow, Harlow Homes, and Paul Bettger property owner, reviewed the following items for a housing development: Items discussed: 1) Proposed 55+ community to be developed as a cul-de-sac located south of Fairview Manor; 2)Shrink right of way requirements for townhouses-duplexes—less yardage required in retirement housing; 3) Infrastructure for water and sewer connections—if more development in area new water and sewer lines would be constructed; 4) For start of project road entrance would be gravel and would be upgraded if area is developed;5) Proposed duplex unit being constructed will have unfinished basement; 6) Start date for one duplex is October, 2018; 7)Will continue to work on zoning regulations for right of way and set back requirements for a 55+ retirement development.

# JEFF NEIMAN, FILLMORE COUNTY SUPERVISOR

Jeff Neiman inquired if the Village Board would be interested in a joint venture with the county for paving the gravel road going to Casey's in the next 2-3 years. General consensus of the board was to consider the venture. Project will be put in the village's 2019 One and Six Year Street Plan. Jeff will gather information on a proposed cost.

# ANGIE MEYER, 300 I STREET DRAINAGE ISSUE

Angie visited with the board regarding drainage by her property located at 300 I Street in Fairmont: 1)Prior to sewer/water improvements drainage not an issue; 2)Difficult for bus driver with mud—school stated would not be able to picked up children; 3)Meyers are foster parents with special needs children—concerned with access to assist children if medical care is needed; 4) Gravel/sand/debris left in yard from project; 5) Requesting the board smooth the area out and the ditch be covered; 6) Pickups driving in area when muddy; 7) Presented property issues with

pictures; 8)Heavily traveled area; 9) Village board and maintenance personnel will look at area on Wednesday evening, September 12th.

## JAMEY PANKOKE, GENERAL MANAGER PERENNIAL

Jamey reviewed information for a comparison of the financial impact and rates if the village were to lease the electric distribution system to Perennial rather than the current practice of operating the electrical distribution system. Current comparisons indicate the village would have a financial benefit to continue operating the electric distribution system.

# TRUSTEE KLIPP, CONTRACT GARBAGE SERVICE

Trustee Klipp inquired if the village could contract with one company to pick up refuse disposal in Fairmont to eliminate some of the truck traffic on streets. Items discussed; 1) Wheel tax on refuse disposal trucks to cover cost of expense on alleys/streets; 2) Possible rules for refuse disposal company; 3) Village will request mapped route from refuse disposal companies operating in town.
