The Village Board of Fairmont, Nebraska met in regular session on Monday, July 15th, 2025, at 7:00p.m. at the Fairmont Village Hall, 635 6th Ave., Fairmont NE. Notice of the meeting was given in advance according to proper notification by posting of meeting notice at Heartland Bank-Fairmont Branch, U.S. Post Office and Fairmont Village Hall. Chairman Rod Ehmen called the meeting to order. Clerk/Treasurer Karen Margheim recorded the minutes. The board members present upon roll call were: Rod Ehmen, Matt Hafer, Victoria Verhage, Bill Schropfer and Stuart Bridges. Visitors to the neeting were: Tyler Salmon, Holly Davenport, Debbie Grant, Paula Hoff, Bob Thompson, Stephanie Chambers, Mike Scheil and Shandra Reinsch. Chairman Ehmen noted that a copy of the Open Meetings Act was posted on the bulletin poard in the council meeting room for public inspection and review. Hafer moved and Verhage seconded to approve the ninutes from June 9th, 2025, Regular Meeting and June 25th, 2025, Special Meeting. Voting: 5 ayes, 0 nays. Motion passed. The Treasurer's Report for June 2025 was placed on file.

Fire Department

Frustee Bridges shared the closing date for the Rural Fire Department to purchase the 401 5th Ave. property is Wednesday, July 16th at 10:30am. Part of the fence will be removed, and the new building will arrive in August. They are hoping to be fully moved in by the beginning of 2026.

Utility Superintendent Report - Mike Scheil

A bid in the amount of \$22,500 from Premier Power was reviewed for electrical changes on "E" Street. This quote was for labor only, most supplies the Village already owns. When this is done an upgrade to the transformer will be needed. A new siren has been ordered by the Fire Department. A couple of weeks ago, lightning was the possible cause for power lost at the water tower. One week later the south well lost power and communication. Johnson Service Company has completed their annual sewer line cleaning and maintenance. The annual budgeted amount for our sewer line naintenance contract was \$12,500. A discussion ensued to replace the transmission in one of the maintenance trucks. Two proposals have been received. The first was from Erdkamp Motors and the other was Aspegren Repair. The work will be completed at Aspegren Repair in Sutton for \$8,500. Gravel has been ordered. The girl's bathroom at the pool needs a new toilet paper dispenser. Dialog ensued over the pool water followed by a conversation on dirt work and gravel.

Aging Services-Shandra Reinsch

The cream can fundraiser served 83 people and brought in \$1,117. Mary Tous Foundation donated funds to cover the expenses. Dialog ensued over hiring a part-time cook. It was decided to offer \$17.50 for a starting wage for one part-time cook with a maximum of 25 hours/week. CPR certification is a requirement for this person. A suggestion was made to check with Senior Services on employment requirements for a part-time Senior Center cook.

Library Report-Stephanie Chambers

During Old Setts, there were over 70 people who attended the 2-EEE entertainment at the Legion. Ginger Wilkins will be available to start working part-time again.

Village Marshal Report - Tyler Salmon

There was a discussion on nuisance properties, feral cats and traffic concerns.

SENDD (Southeast Nebraska Development District) Annual Membership-\$603.00

A motion was made by Verhage, seconded by Schropfer to approve our annual membership with SENDD. Roll call vote - 5 ayes, 0 nays. Motion passed.
