The Village Board of Fairmont, Nebraska met in regular session on Monday, September 12th, 2022 at 7:00p.m. at the Fairmont Village Hall, 635 6th Ave., Fairmont NE. Notice of the meeting was given in advance according to proper notification by posting of meeting notice at Heartland Bank-Fairmont Branch, U.S. Post Office and Fairmont Village Hall. Chairperson Donald A Moses called the meeting to order. Clerk/Treasurer Karen Margheim recorded the minutes. Board members present upon roll call were: Don Moses, Tricia Galusha-Chapman, and Jack Slocum. Absent Austin Jarosz and David Seggerman. Visitors to the meeting were: Rod Ehmen, Shandra Reinsch, Victoria Verhage, Mike Scheil, Tyler Salmon, and Anna Yates. Chairperson Moses noted that a copy of the Open Meetings Act was posted on the bulletin board in the council meeting room for public inspection and review. Slocum moved and Chapman seconded to approve the minutes of the August 8th, 2022 Regular meeting, to approve the minutes of the August 22nd, 2022 Special meeting and August 29th, 2022 Special meeting. Voting: 3 ayes, 0 nays, 2 absent. Motion passed. The Treasurer's Report for August 2022 was placed on file.

Budget Hearing-review 2022-2023 Budget documents

At 7:01pm a motion was made by Chapman, seconded by Slocum to open the hearing. Roll call vote -3 ayes, 0 nays, 2 absent. Motion passed. After no comments or questions were received, at 7:02 a motion was made by Chapman, seconded by Slocum to close the hearing. Roll call vote -3 ayes, 0 nays, 2 absent. Motion passed.

Public Hearing for Setting Tax Levy-review of proposed levy for Fiscal Year 2022-2023

Resolution 2022-07 Budget/Property Tax Request for Fiscal Year 2022-2023

A motion was made by Slocum, seconded by Chapman to approve Resolution 2022-07 setting the Budget/Property Tax Request for Fiscal Year 2022-2023 at \$387,888.90 for the General Fund and \$257,097.98 for the Bond Fund. Roll call vote – 3 ayes, 0 nays, 2 absent. Motion passed.

One & Six Year Road Plan Hearing & Consideration of Resolution 2022-08 One & Six Year Road Plan

At 7:05pm a motion was made to open the hearing by Chapman, seconded by Moses. Roll call vote – 3 ayes, 0 nays, 2 absent. Motion passed. At 7:06pm a motion was made to close the hearing by Slocum, seconded by Chapman. Roll call vote – 3 ayes, 0 nays, 2 absent. A motion was made by Chapman, seconded by Slocum to approve Resolution 2022-08 for the One & Six Year Road Plan. Roll call vote – 3 ayes, 0 nays, 2 absent. Motion passed.

Drug Testing Policy

A review of the updated random drug testing policy was conducted. A change included after a positive drug test an employee has the option for treatment at the employee's expense (after insurance coverage) in order to keep their job. After a second positive test, employment will be lost. There was also a question regarding prescription drugs and HIPPA regulations. Updates to the policy will be made by the Village attorney.

League of Nebraska Municipalities Membership Dues-\$3,948.00

League of Nebraska Municipalities Membership-Utilities Section Dues-\$482.00

A motion was made by Moses, seconded by Chapman to approve paying dues in the amount of \$482.00 to the League of Nebraska Municipalities for membership with the utilities section. Roll call vote -3 ayes, 0 nays, 2 absent. Motion passed.

Glenwood Communications Fiber & ARPA Funds

A motion was made by Chapman, seconded by Slocum to reimburse Midwest Mobile Tech for half of the expenses they incurred to bring Glenwood fiber to town using ARPA funds. The amount of the reimbursement is \$17,427.30. Roll call vote – 3 ayes, 0 nays, 2 absent. Motion passed.

Senior Center Checking Account

Nothing will change with the account at this time. It will be discussed in further detail by the Senior Center board members.

Utility Superintendent Report – Mike Scheil

Utility Superintendent Scheil discussed some of the items on his daily report. There has been a start to the lagoon project. The bottom has been shredded. Great Plains Power has completed the north electrical project. The anticipated end date for the paving project by Casey's was talked about. Steve Parr, JEO Consulting Group, Inc. will be typing a letter over the expected timeline.

Clerk/Treasurer Report-Karen Margheim

Clerk Margheim gave an update from the latest weekly NPPD webinars. A bond payment in the amount of \$15,886.25 will be made this week. When a holiday falls on a Payroll processing Monday, the pay date will need to be pushed back a day to Thursday of that week instead of Wednesday.

1. The 2022-2023 property tax request be set at:

- 2. The total assessed value of property differs from last year's total assessed value by -8.31 percent.
- 3. The tax rate which would levy the same amount of property taxes as last year, when multiplied by the new total assessed value of property would be 0.817984 per \$100 of assessed value.
- 4. The Village of Fairmont proposes to adopt a property tax request that will cause its tax rate to be 0.748266 per \$100 of assessed value.
- 5. Based on the proposed property tax request and changes in other revenue, the total operating budget of the Village of Fairmont will increase (or decrease) last year's budget by -22.79 percent.
- 6. A copy of this resolution be certified and forwarded to the County Clerk on or before October 15, 2022.

ORDINANCE #22-550 Budget FY 2022-2023

Section 1.
