The Village Board of Fairmont, Nebraska met in regular session on Tuesday, October 10th, 2023 at 7:00p.m. at the Fairmont Village Hall, 635 6th Ave., Fairmont NE. Construction cost of the project is \$55,600. Split 50% by each party, the Village agrees to pay \$27,800. The lift station overflowed and a pressure sensor and a secondary sensor were both replaced. Tree removal estimates were received for three trees at the pool park. The estimates were from: Dylan Axline-\$9,000; Jake Herman-\$8,100 and Bob Robinson-\$5,000. The decision to go with Bob Robinson was made due to the ability to remove stumps also. Some new concrete was poured at the pool.
